2. Amounts of subsidies for new installation have been changed.



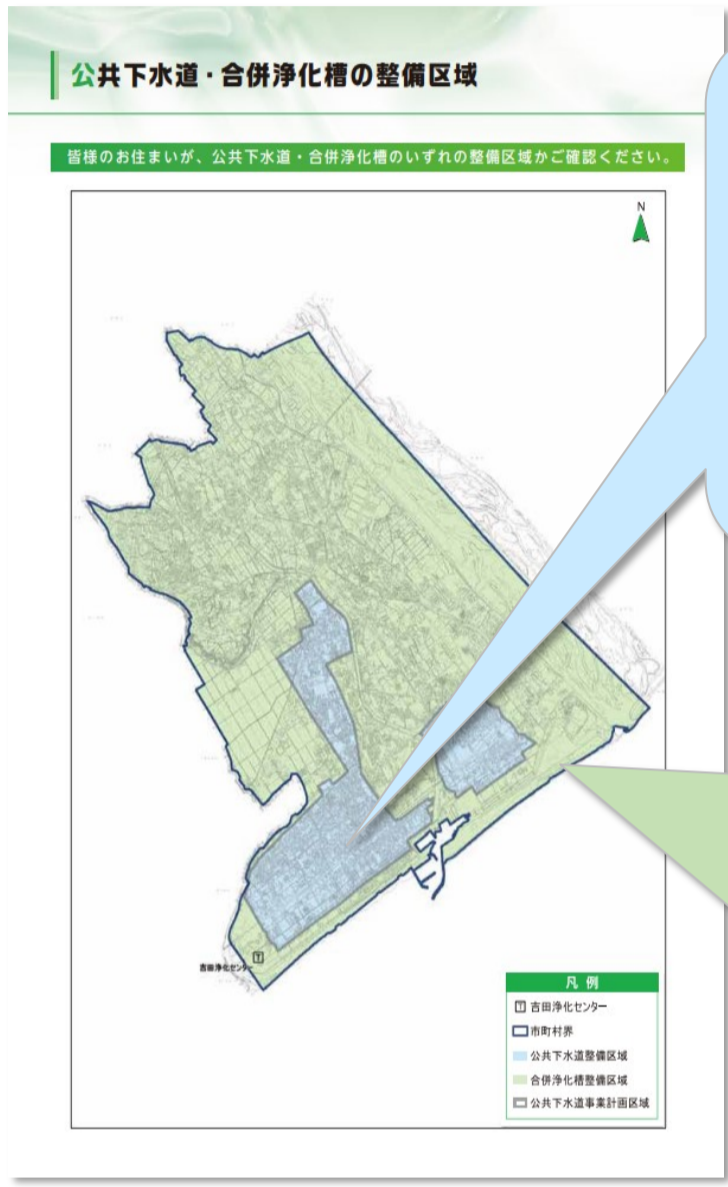

Those who want to install septic tanks in the light-blue colored area with access to public sewerage system and want to apply for subsidies, need to have the approval of Yoshida Town Gerverment before installation. Please consult with the staff in charge at Sewerage System Division ahead of time.

※ For those who want to install combined treatment septic tanks in the light-green colored area, consulation are not required beforehand.
